I UNDERSTAND THE DATE I HAVE REQUESTED WILL NOT BE RESERVED UNTIL A \$50.00 DEPOSIT IS PAID, BUT  
WILL BE REFUNDED AS LONG AS THE DUNK TANK IS RETURNED ON TIME AND IN THE SAME CONDITION IT WAS  
RECEIVED. I UNDERSTAND THE TOTAL COST LISTED ABOVE MUST BE PAID IN FULL ON THE START DATE.

I ALSO AGREE TO THE FOLLOWING TERMS:

THERE MUST BE AT LEAST ONE ADULT SUPERVISING THE DUNK TANK AT ALL TIMES, MAKING SURE IT IS USED  
SAFELY. THERE IS ONLY 1 PERSON ALLOWED IN THE TANK AT A TIME AND THE PARTICIPANTS) MUST BE AT  
LEAST 50" TALL. ALL PARTICIPANTS MUST AGREE TO FOLLOW ALL RULES LISTED ON THE TANK AND THE PORT  
CLINTON F.O.P. 79, RESERVES THE RIGHT TO STOP WITHOUT WARNING, TO CHECK THAT THE DUNK TANK IS  
BEING OPERATED ACCORDING TO THE RULES, IF FOUND NOT TO BE FOLLOWING THE RULES THE DUNK TANK  
WILL BE SHUT DOWN WITH NO REFUND. IF THE DUNK TANK IS NOT RETURNED AT THE TIME PROMISED, AD-  
DITIONAL RENTAL DAYS WILL BE ADDED.

IT IS THE RESPONSIBILITY OF THE PERSON, GROUP, OR ORGANIZATION RENTING THE DUNK TANK TO SUPPLY  
THEIR OWN INSURANCE AND AGREE TO HOLD HARMLESS THE PORT CLINTON F.O.P. LODGE No.79, ITS OFFI-  
CERS, ITS PERSONNEL, AND THE GOVERNING BODY OF THE PORT CLINTON F.O.P. LODGE No. 79, FROM ANY  
CLAIMS OR LIABILITY RESULTING FROM THE USE OF THE DUNK TANK.
